ELLSWORTH PUBLIC SCHOOL REGULAR SCHOOL BOARD MEETING

School Library Ellsworth, Minnesota Monday, December 19, 2022

The regular school board meeting was called to order by Chairperson Ryan Heikes at 6:00 p.m. A roll call revealed all members present. The Board of Education opened the meeting by reciting the Pledge of Allegiance.

Staff present: Amy Labat, Dave Ackerman, Darcey Groen, Judy Huisman & Chelsea Patrick.

Visitors: Joyce Jacobs - Nobles County Auditor, Larry Lewis & Jennifer Harms.

A motion was made by Buntjer and seconded by Jenniges to approve the meeting agenda as presented. Motion carried.

A motion was made by Lynn and seconded by Lefdal to approve the minutes of the regular meeting held on November 21, 2022. Motion carried.

Joyce Jacobs, Nobles County Auditor, presented information on the tax levy.

The Board of Education reviewed the Student Activity Fund.

Becca Dreesen reported on these items for EPTO: Shirt Sales. Next meeting will be January 10, 2023.

The following resolution was moved by Becca Dreesen.

RESOLUTION ESTABLISHING COMBINED POLLING PLACES
FOR MULTIPLE PRECINCTS AND
DESIGNATING HOURS DURING WHICH THE POLLING
PLACES WILL REMAIN OPEN FOR VOTING
FOR SCHOOL DISTRICT ELECTIONS NOT HELD
ON THE DAY OF A STATEWIDE ELECTION

BE IT RESOLVED by the School Board of Ellsworth School District No. 514, State of Minnesota, as follows:

- 1. Pursuant to Minnesota Statutes, Section 205A.11, the precincts and polling places for school district elections are those precincts or parts of precincts located within the boundaries of the school district which have been established by the cities or towns located in whole or in part within the school district. The board hereby confirms those precincts and polling places so established by those municipalities.
- 2. Pursuant to Minnesota Statutes, Section 205A.11, the board may establish a combined polling place for several precincts for school district elections not held on the day of a statewide election. Each combined polling place must be a polling place that has been designated by a county or municipality. The following combined polling places are established to serve the precincts specified for all school district special and general elections not held on the same day as a statewide election:

Combined Polling Place: Grand Prairie Township Hall 206 East 2nd Avenue Ellsworth MN 56129 "This combined polling place serves all territory in Ellsworth School District No.514 located in Grand Prairie Township; West Side Township, Kanaranzi Township, Little Rock Township, Ransom Township, the City of Ellsworth, Nobles & Rock County, Minnesota."

Note: See Section 2.3.2 of the Election Manual regarding changing polling places in the case of an emergency or if the polling place is no longer available.

*3. Pursuant to Minnesota Statutes, Section 205A.09, the polling places will remain open for voting for school district elections not held on the same day as a statewide election between the hours of 8:00 o'clock a..m. and 8:00 o'clock p.m.

Note: See Section 3.6 of the Election Manual regarding certain restrictions on voting hours.

- 4. The clerk is directed to file a certified copy of this resolution with the county auditors of each of the counties in which the school district is located, in whole or in part, within thirty (30) days after its adoption.
- 5. As required by Minnesota Statutes, Section 204B.16, Subdivision 1a, the clerk is hereby authorized and directed to give written notice of new polling place locations to each affected household with at least one registered voter in the school district whose school district polling place location has been changed. The notice must be a non-forwardable notice mailed at least twenty-five (25) days before the date of the first election to which it will apply. A notice that is returned as undeliverable must be forwarded immediately to the appropriate county auditor, who shall change the registrant's status to "challenged" in the statewide registration system.

The foregoing resolution was seconded by Lisa Lynn. Motion carried.
