School Library Ellsworth, Minnesota Wednesday, January 17, 2024

The organizational meeting was called to order by Chairperson Ryan Heikes at 6:00 p.m. A roll call revealed all members present. The Board of Education opened the meeting by reciting the Pledge of Allegiance.

A motion was made by Buntjer and seconded by Lefdal to approve the meeting agenda with one addition. Motion carried.

Nominations were called for the position of Chairperson to serve a one-year term.

Randy Buntjer nominated Ryan Heikes to serve as Chairperson. A motion was made by Buntjer and seconded by Lynn to close nominations and direct the acting clerk to cast a unanimous ballot to elect Ryan Heikes as Chairperson. Motion carried.

Nominations were called for the position of Vice-Chairperson to serve a one-year term.
